Terms of Reference:

Skateboard Coaching Commission

1.Title

1.1 The group shall be called the UK Skateboard Coaching Commission

2. Overview

These terms of reference describe the purpose of the Commission, the process they will be guided by, the authority they have and the requirements regarding confidentiality for those engaging with them.

3. Accountability

3.1 The Skateboard Coaching Commission is accountable to the Coach Development Lead, who will chair the Commission for carrying out the responsibilities that are delegated to it within these Terms of Reference.

4. Purpose

The UK Skateboard Coaching Commission is designed to build opportunities for interaction and collaboration between UK Skateboard Coaches and Skateboard GB. The Coach Development Lead will set out learning gathered from the previous years' development of SBGB Coach Education and offer a chance to feedback on its future direction.

The Purpose of the Skateboard Coaching Commission is to:

- 4.1 To Provide advice, expertise and recommendations to support the development of Skateboard GB coaching qualifications, standards and training including the structures and processes around qualification
- 4.2 Update the Coach Development Lead on developments within Skateboard Coaching and emerging trends
- 4.3 To provide a sounding board and place of expertise to support Skateboard GB in the wider development of a world-class coaching pathway

The Chair of UK Skateboard Coaching Commission will be responsible for ensuring that outcomes or conclusions are reached and for summarising any recommendations. UKSCC members will have a key role in disseminating and advocating for those changes which are made as a result of conclusions and recommendations made by UKSCC.

Process

Meetings will be held every two months. Every effort will be made to hold the meeting on the preferred date indicated by each Commission member but may be held at another time if this is not possible. Meetings will be mostly online, however, where possible we will attempt to run in person meet ups of the commission. Meetings will be guided by a standard agenda – detailed below - which will describe the format of the meeting.

Smaller topics can be raised during the open floor session. For topics which will require prior reading or consideration of material or if any Commission members would like to focus the Commission meeting on a specific topic they should submit this to the Coach Development Lead five working days prior to the meeting which will be circulated to all Commission members for pre-reading.

Meeting Notes

An individual (employed by SBGB) will act as the formal note-taker to ensure capture of the pertinent discussions and to ensure a common understanding of the outcomes. The notes will include any recommended actions where relevant and/or other feedback. The notes from the meeting will normally be made available within 5-10 working days of the meeting.

Confidentiality

All members and attendees will treat all Commission papers and materials as confidential unless indicated otherwise or unless they are already in the public domain.

Application Process

Application Form

Demographics Section:

 This could be in any aspect of skateboard coaching. We'd like to hear what you would prioritise and your reasoning. This will give us insight into the issues that matter to you and why.

Selection Process

Applicants will be selected based on the answers given in their application. Skateboard GB will also endeavour to ensure a mix of demographics, geographical locations and range of coaching experience.

Answer Scoring

Each answer will be scored in the following criteria:

- 0 No answer given
- 1 An answer was given but it didn't address the question
- 2 A relevant answer was given but no examples or insight were offered
- 3 A relevant answer was given, including examples and insight from experience
- 4 An ideal answer was given, including exceptional examples and insight from experience.
